2. We agree to pay interest free security deposit through demand draft/cash in favour of RSD Expositions.
  - For booths measuring up to 60 sq. mtrs. Rs. 40000/-
  - For booths measuring above 60 sq. mtrs. Rs. 80000/-
3. Please note that the Demand Draft has to be submitted at least one week before the event that is latest by 14<sup>TH</sup> MARCH 2026. This amount will be refunded post the show subject to the following:

I/we shall complete the Booth build-up by 7 pm on 27<sup>TH</sup> MARCH 2026. A grace period of 2 hours will be allowed i.e. from 7 pm to 9 pm but after this extended time, no concession will be given and a sum of Rs 5000/- per hour will be charged as compensation fine for failing to adhere to the timelines.
